I know that marijuana is prohibited by federal law.

As a Customer, I voluntarily assume full responsibility for any risk, loss, damage, or personal injury (including death) that I sustain as a result of being a customer or resulting from my possession or use of alcohol or marijuana and release Detour Bend from any and all claims related thereto, including any implied warranties of merchantability or fitness for a particular purpose.

I hereby KNOWINGLY AND VOLUNTARILY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS Detour Bend its owners, agents, employees, and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorney's fees) which are related to, arise out of, or are in any way connected with my participation in or in any way related to my being a customer of Detour Bend and my participation in the Tour

It is my express intent that the above provisions of the Waiver, Release, Indemnification & Agreement (the "Release & Agreement") shall bind the members of my family and spouse if I am alive, and my heirs, assigns, and personal representative if I am deceased, and that the Release & Agreement is deemed a Release, Waiver, Discharge, and Covenant not to sue Detour Bend or any of its affiliates, officers, directors, agents, representatives, and employees.

As Customer, I further agree to the following terms and conditions of this agreement:

- 1. Payments made by Customer to Company are taken in full at the time of booking. Cancellations received 5 days prior to the tour date will receive 100% refund, any cancellations received 48 hours prior to tour date will receive 50% refund or reschedule at no extra charge (subject to availability) and any cancellations received less than 48 hours or no-shows are not eligible for a refund or reschedule;
- 2. Customer understands that the services and/or planned activities provided by Company are subject to change without prior notice to Customer;
- 3. Included in the services provided by the Company is a tour wherein Customer and other individuals are permitted to consume alcohol and cannabis during the "Tour," but subject to the Tour's conditions. The consumption of alcohol and cannabis is only allowed in private and if there is a partition physically separating Customer from the driver of the vehicle, or if it takes place at licensed and approved State of Oregon locations. Customer agrees that Customer will not violate any laws with respect to the purchase or use of cannabis on the Tour and consumption of alcohol or cannabis in public view;
- 4. Customer will not bring any other individual on the Tour who is not at least twenty-one (21) years of age, valid identification required, and who has not signed a waiver;
- 5. As stated above, the Tour involves potentially dangerous activities and the consumption of cannabis and/or alcoholic beverages, therefore Customer assumes the risks associated with the services provided and cannabis and alcohol consumption and takes full responsibility for his/her own actions and safety and the safety and welfare of others;
- 6. Customer will not bring their own alcoholic beverages on the Tour. Notwithstanding the foregoing, Customer is permitted to purchase and bring those alcoholic beverages on the Tour;
- 7. The Company reserves the right to seize any cannabis or alcoholic beverages from Customer if Company

believes, in Company's sole and absolute discretion, that Customer is being unsafe or unruly;
